GOVERNING INSTRUMENT

TTP is governed by the Memorandum and Articles of Association. It was set up as a Company by Guarantee with Members' need to guarantee an amount not exceeding the sum of S\$1.00. The number of directors shall be determined by the Board of Directors but shall not be less than three at one time.

PRINCIPAL ACTIVITIES

The principal activities of the company are to promote and develop performing arts and to produce and present drama, dance and other cultural activities.

REVIEW OF YEAR 2015/2016

TTP runs the regular classes for both adults and children.

The regular courses conducted during the year were Chinese Aerobics for the Women, Mandarin Speech & Drama Courses called Story Banq for ages 7 to 9, Drama Class for ages 10 to 12, and Play-In-Arts for ages 4 to 6.

An in-house performance called *The Little Windmills Take The Stage* involving the Mandarin Speech & Drama Students was held at Queenstown Community Centre Auditorium to showcase the progress of the students to their parents.

TTP produces Chinese and English productions held at various locations for different audiences ranging from adults to children. We remain committed to stage entertaining, accessible and yet provocative works for our audiences.

To commemorate our 50th Anniversary, we started off the year with an original Wu Xia play, *Legends of The Southern Arch.* It was a bold attempt at bringing a genre more familiar to us on television and film. The outcome was an exciting stage interpretation that was received

The second half of the year saw the return of *M1 Chinese Theatre Festival*. This year's festival was made up of 6 main programs, and we continued to reach out across the spectrum to bring something for all kinds of audiences. As we accumulated experiences from previous years, the fringe activities this year were also more diverse, and that is supported by a Green Room that was present throughout the entire festival as a place to find information as well as a space to mingle and dialogue with artists and fellow audience members.

TTP Lab embarked on its 3rd year, ending 2015 with an impressive showcase of 10 monologues all created by members of the Actors' Lab in the production *Upstream*. Reviewers' Lab continued to build its critical muscles with works published on line through the portal *re-Viewers*.

On the education front, we continue to accumulate on the projects that we have been growing over the years. The *National Story Challenge* reached out both through the annual competition as well as in schools through performances and workshops. Similarly, our outreach efforts through guiding CCA activities, theatre exposure programs and touring performances continued throughout the year

For the 6th time, we held the *Philippe Gaulier Master Class* in collaboration with the NAC. The Master Class is part of TTP's education and outreach initiative, and shows

our continuing commitment to nurture, develop and train our artists and practitioners with exciting and challenging programmes.

This year, in partnership with NAC, we were able to engage in a different way through re- starting our corporate program, *Setting the Stage For Service*. Using elements from actors training, we worked with companies to train their service staff. The outcome was very encouraging and we hope to develop this area of our capabilities further.

To commemorate our anniversary this year, we also decided to begin publishing some or our original works that were created in the last 10-12 years. Intended as an ongoing series, so far we have printed 3 volumes, they are *Lao Jiu: The Musical, The Bride Always Knocks Twice* and scripts from *Poor Theatre*.

TTP's work is currently supported by 7 full time artistic and production staff, 11 full time administrative, marketing and education staff, 1 part-time Education and Outreach Advisor and 1 part-time finance officer.

Review of Financial State, Explanation of Major Financial Transactions and Reserves

We recorded a surplus \$ 536,546 for the year with a total income of S\$ 2,705,495 against a total expenditure of S\$ 2,168,949.

TTP is on a 3-year major grant scheme with the NAC and the current grant period extends to March 2017.

TTP's assets and reserves are held solely for the use of the charity. Our reserves as at 31st March 2016 is \$ 1,910,418. We have recorded a 0.88: 1 ratio of Reserves to Annual Operating Expenditure (Target 3 : 1). We are constantly monitoring our income streams by doing a forecast/budget for the next year and looking for new income sources while keeping tabs on the expenditures balancing Artistic and financial decisions.

Policy relating to the Management and Avoidance of Conflict of Interest

All transactions for TTP are approved by two officers in charge (according to the Delegation of Authority Matrix). All business transactions are done at arms length. The Board of Directors have signed a declaration form to declare any conflict of interest. The Board of Directors will reframe from voting if there is a conflict of interest issue arise.

Future Plans and Commitments

Our office and rehearsal space will be relocated to a new premise on 54 Waterloo Street on 27th June 2016. We will have our very own black box called *The Practice Space*.

TTP's regular classes for adults and children will continue and we will look into the possibility for expansion. We will continue to review our curriculum in order to be relevant to the current needs of students.

Investment into training of actors, playwrights and theatre audience outreach with the Practice Lab, will be strengthened further.

2017 brings back a 1st rerun of the Musical *Lao Jiu* and the return of Chinese Theatre Festival 2017 with a line-up of more exciting shows from Singapore, Hong Kong, Taiwan and China.
